Mr. Wightman read and proposed Resolution #20 To Allow Only Town of Plymouth Equipment in the Town Highway Garage. After some discussion, Mr. Elsworth made a motion to table the resolution so it can be revised. Mr. Manwarren seconded the motion. The Board was polled and the motion was carried with three yeses and one no. Councilperson Wightman voted no and Councilperson Fairbanks was absent.

Mr. Manwarren read Resolution #20 (renumbered because the original #20 was tabled.) Requiring the Town Highway Superintendent to Submit a Monthly Fuel Usage Report. After some discussion, Mr. Wightman made a motion to approve Resolution #20. Mr. Manwarren seconded the motion. The Board was polled and the motion was carried with three yeses and one no. Supervisor Murray voted no and Councilperson Fairbanks was absent.

Mr. Wightman read and proposed Resolution #21 Requiring the Town Supervisor to Post a Monthly Financial Statement on the Town Webpage. Mr. Manwarren seconded the resolution. The Board was polled and the resolution was passed with three yeses and one no. Supervisor Murray voted no. Councilperson Fairbanks was absent.


The bills were reviewed and signed. Mr. Wightman made a motion to pay the bills. Mr. Elsworth seconded the motion. The Board was polled

and the motion was carried with four yeses and no nos. Councilperson Fairbanks was absent.

Mr. Elsworth made a motion to accept the resignations from Mr. O'Hara, Mrs. Jackson, and Ms. Kreiner, that were read earlier. Mr. Wightman seconded the motion. The Board was polled and the motion was passed with four yeses and no nos. Councilperson Fairbanks was absent.

Mr. Wightman made a motion to adjourn the meeting. Mr. Manwarren seconded the motion. The Board was polled and the motion was carried with four yeses and no nos. Councilperson Fairbanks was absent. The meeting was adjourned.
